**ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the Republic of the Philippines.

THAT WE HEREBY CERTIFY:

FIRST: The name of the said association shall be:

KABATAANG PILIPINO, INC. (KPI)

SECOND: That the purpose or purposes for which such association is incorporated are:

- Provide an opportunity to financially challenged Filipino youth to finish their primary, secondary, tertiary, or vocational education through financial assistance, sponsor networking, or scholarship information and assistance;
- Provide developmental and/or training programs, activities, or events that would support or enhance the grantees' experience as KPI scholars;
- Provide other acts of charity to help other sectors of the society particularly the youth to cope up with poverty, disaster, or misfortune; and,
- Pro-actively promote the enhancement of the quality of Philippine education in the belief that "education" is the answer to the country's progress and development and people empowerment.

THIRD: That the place where the principal office of the association is to be established is at:

FOURTH: That the term for which the association is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.

EIGHTH: That no part of the income which the association may obtain as an incident to its operation shall be distributed as dividends to its members, trustees, or officers subject to the provisions of the Corporation Code on dissolution. Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provision of Title XI of the Corporation Code of the Philippines.


NINTH: That **ROWENA P. KABIGTING** has been elected by the members as Treasurer of the association to act as such until his/her successor is duly elected and qualified in accordance with the By-Laws; and that as such Treasurer, she has been authorized to receive for and in the name and for the benefit of the association all contributions or donations paid or given by the members.



ELEVENTH: That the association shall comply with the requirements for non-stock corporations in the course of its operation.






